- Welcome Mike Frisbie, COO of SAWS.
 - Mr. Frisbie welcomed everyone to San Antonio. He announced that the Dos Rios Wastewater Treatment Plant has been renamed to the 'Steven M. Clouse Water Recycling Center'. Mentioned the 50 year anniversary of NACWA. There are a lot of challenges for everyone in attendance: aging infrastructure, aging workforce, workforce development and new regulations. SAWS is going to do a MasterPlan for its Wastewater Treatment Plants.

• TDS Committee [WEAT, TACWA and WateReuse Texas] Update: The committee is meeting with TCEQ on Tuesday September 17, 2019.

Janet Sims:

- The Clean Water Act Analytical Methods Update Rule (MUR) Stakeholder Meeting was held on August 20. TCEQ Staff went over the MUR, there implementation plan and discussed the four new parameters that were added to the water quality standards list. TCEQ has established NELAC Accreditation for the new methods and the new methods need to be used by August 28, 2019. TCEQ requested input on the presentation.
- TCEQ is planning on holding a Pretreatment Stakeholder Meeting on Thursday September 19.
 Topics will include how the method update rule will impact the Pretreatment Program, other
 issues brought up at the MUR meeting and issues brought up at the EPA Region 6 Workshop
 in Denton.
- There will be a Surface Water Quality Advisory Workgroup Meeting is scheduled for October 15.

Julie Nahrgang:

- State Legislative Update: The State Legislature is no longer in session. Not a lot of stuff happening. We should see interim reports in a few months (Oct thru Dec).
- Senate Bill 7 and 8 which create the funds and mechanisms for the flood plan are now in effect. The funds for the plan will go to the voters in November.
- Federal Update: PFAS is still a hot topic. There are around 500 laws being discussed across the nation. The blending rule is still forth coming. The 2015 WOTUS has been rolled back.
- WEFTEC is coming in a few weeks, Water Policy Fly-In Apr 27-30 2020.
- New TACWA website and database will be coming soon. Currently the new site is being tested. Should be released by the middle of October 2019.
